This application form allows families to submit an application for enrolment of their student(s) at Yattalunga Valley Christian School. To cover processing costs a non-refundable fee of \$75 will be charged per application to enrol.

- Copy of the prospective student's birth certificate
- Copies of the two most recent school reports if already attending school elsewhere
- Current specialist and medical reports including evidence of diagnosis (e.g. allergies, asthma, diabetes, psychological, OT, speech)
- Any court or parenting orders that exist pertaining to the guardianship arrangements for the child
- Recent photo of the student
- Immunisation History Statement

Students applying for YVCS must provide a current report from a specialist medical practitioner or registered psychologist with appropriate clinical experience that details the nature of the student's disability. Documented evidence must indicate a developmental disability affecting the verbal and non-verbal communication and social interaction that significantly affects the child's ability to learn in the school context. There must also be information provided of a functional assessment consistent with the diagnosed disorder. To ensure the school is adequately equipped to meet the needs of your child, it is a requirement of this Application for Enrolment that all current specialist reports be provided. More detail will be gathered at the assessment interview.

- Copies of all current medical and specialist reports including evidence of diagnosis
- Recent photo of the student
